



## RENTAL AGREEMENT FOR GREEN WASTE TRAILER

I, \_\_\_\_\_, am the owner/tenant (circle one) of the property located in Salt Lake County at \_\_\_\_\_. I request use of a debris trailer from Salt Lake County Special District No. 1 and agree to the following conditions:

### PLEASE INITIAL EACH LINE:

\_\_\_\_\_ I understand there is a \$30.00 service fee, payable in advance, for the green waste trailer.

\_\_\_\_\_ I understand the \$30.00 is non-refundable if I cancel the trailer; however, I will be allowed to reschedule another delivery date within 90 days of the original scheduled delivery date for a \$20.00 fee. After 90 days of the original scheduled delivery date all service fees are forfeited.

\_\_\_\_\_ I am **Not** a Contractor and I will Not allow the trailer to be used by a Contractor.

\_\_\_\_\_ The trailer must be placed entirely on my property and cannot impede or obstruct sidewalks or roadways. The large trailer requires an area of 26' x 10.' The trailer box holds 18 cubic yards and measures 16' long, 8' wide, and 4' deep. The short trailer is available for those with less space. It requires an area of 22' x 10.' The trailer box holds 14 cubic yards and measures 12' long, 8' wide and 4' deep.

\_\_\_\_\_ If the location I specify for the trailer is inadequate due to a steep driveway, is blocked by any obstruction, or the driver encounters any other problem, the trailer may not be delivered or may not be placed exactly where I specified. (This will be at the driver's discretion).

\_\_\_\_\_ I agree to pay an additional \$100 fee if I move the trailer after delivery.

\_\_\_\_\_ I understand that I am responsible for the items placed in the trailer. The trailer shall only be used for green waste yard cleanup (i.e., tree limbs, branches, shrubbery, grass trimmings, unpainted wood without nails or hardware, etc). I will **NOT** authorize or use the trailer for the following:

- Bags (regardless of content), boxed material, sod, dirt or paper
- Remodeling, renovating or construction debris, treated wood
- Hazardous waste such as asbestos, solvents, paints, hydrocarbons, oil products, pesticides, herbicides, etc.
- Propane, gasoline, or freon
- Batteries, tires, engines, or transmissions
- Tanks of any kind, barrels, or refrigerators

\_\_\_\_\_ If I decide to use the trailer for bulk waste, I understand I must contact the Sanitation office AND fill out the Rental Agreement for Bulk Waste Trailer form AND pay the additional \$70.00 service fee at least 24 hours prior to pickup. Failure to contact the office will result in violation of the Green Waste agreement form and result in an additional \$100.00 charge and an additional \$50.00 per ton for the entire load.

\_\_\_\_\_ I agree to pay an additional \$50.00 if the load is not tarped at the time of collection or the doors are not fully closed. I will not fill the load above the top of the trailer. I agree to cover and secure the load with the tarp and bungees provided.

\_\_\_\_\_ I understand the trailer will be delivered anytime between 7:00 am – 5:00 pm on the scheduled delivery day. The trailer will be picked up anytime after 7:00 am on the scheduled collection day. **If the trailer cannot be picked up at this time due to obstructions I understand I will be charged a \$100 fee. The delivery/pickup schedule follows:**

\_\_\_\_\_ I agree to pay all collection and attorney fees incurred in the event this matter is referred to the Salt Lake District Attorneys Office for enforcement. Failure to pay this debt may result in the placement of the debt on my property tax and/or attachment or lien upon my property if I fail to pay the debt with my property taxes.

\_\_\_\_\_ I release Salt Lake County and its employees from any damages resulting to me or my property during the placement, stay or removal of the trailer on my property whether or not I am present when the trailer is delivered or collected.

\_\_\_\_\_ I am **NOT** the owner of this property, then this agreement must be signed and notarized by the homeowner. In the event the tenant fails to pay the costs incurred, the property owner will ultimately be held responsible for the charges.
